4. Consent Agenda

- a. Approval of Meeting Minutes: August 14, 2013

5. Discussion & Action Items

a. Principal's Report

Principal Westbrook reported on:

- CSCE hired 2nd resource specialist at 75%. This addition is helping build a more robust SPED team
- The mental health cost should be fully reimbursable If SELPA's true to word
- The school is getting up and running faster than in year's prior on inputting student data into Power School thanks to the hard working staff
- CSCE has held two assemblies, one with John Oubre from Brothers on the Rise and one led by faculty and spotlighting playground rules; both focused on building peaceful school culture
- -The back to school night had to be changed so Administration is rescheduling the board staff dinner
- No pull outs during main lesson is allowing resource and intervention staff to help children get settled in and start learning
- The new breakfast routine further helps accelerate children's settling in for learning

Board advised:

- CSCE is in 2012-13 the Lowest performing charter in Oakland except for 100 Black Men
- Staff and board must set double goal of getting ready for common corps and raising achievement
- Staff must focus on whether kids are on standard as measured by standards aligned assessment
- If leadership does not secure higher student achievement, the support to replicate won't be there
- ASPIRE benchmark test is one standards-aligned, tested and acceptable measure
- It's not about test prep but continuous assessment
- On a daily basis teachers need to learn to inquire, where are students and where to go
- For those who are not proficient, the assessment has to be more intensive, with higher frequency
- Leadership may take a page from ASPIRE: Every day teachers are giving report to principal identifying: here is what we did, what she did and did not learn; homework, after school work, assessments used
- It's key to figure out how we link our inquiry on braiding Waldorf & Open Court to standards in reading skills and sub skills
- At next board meeting, provide report on end of unit assessments in Math and ELA
- CSCE owes it to families of student below and far below, and possibly those not at grade level, to discuss where they are and what the plan is to support the child to proficiency
- Board and admin need a sense of the progress being made
- b. 2013 CST Results: Report and Strategic Response (Oberman/Westbrook)
 - Dr. Oberman introduced Board to CSCE Reading North Star, a programmatic statement developed summer 2013 with overview of CSCE strategy to bring all to grade level proficiency in reading
 - Principal Westbrook presented the CST data and offered analysis and assessment calendar and plan

Director Oberman reports:

- The focus of this meeting is on the Single School and District Plan (SSDP) end of year goals of bringing all students and sub groups to 70% proficient, and brief overview at beginning of document Board advises:
- Take out the comparison to other schools in the district with 660 or lower on API
- Include charters such as Light House and ASPIRE and show how they raised their achievement from 660 and lower to 800's and beyond over 5 years

Ms Meyer moved to approve SSDP pending edits offered by Mr. Hanley.
